ВСТУП

Навчальна дисципліна «Іноземна мова за професійном спрямуванням» викладається студентам освітньо-кваліфікаційного рівня «бакалавр» напряму підготовки «Правознавство» в циклі гуманітарних та соціально-економічних дисциплін.

Mетою курсу «Іноземна мова за професійним спрямуванням» є формування у студентів професійних іншомовних компетенцій, що сприятиме їх ефективному функціонуванню в культурному розмаїтті навчального та професійного середовища.

В результаті вивчення курсу студенти повинні *знати*: структурносемантичні особливості іншомовної термінології юридичного профілю; різні структурні види іншомовних юридичних термінів: терміни слова, термінологічні словосполучення, абревіатури; юридичні терміни та засоби їх перекладу; граматичний мінімум, який охоплює ключові положення морфології та синтаксису й дозволяє правильно розуміти зміст іншомовних джерел.

Основні завдання курсу:

- поповнити словниковий запас студентів для посилення їх висловлювальних можливостей;
 - стимулювати активне обговорення сприйнятої інформації в аудиторії;
- ознайомити студентів з юридичними термінами, мовними кліше, які домінують у сучасній англійській мові;
- актуалізувати знання практичної граматики в ході побудови монологічного та діалогічного мовлення;
- вдосконалити навички усних доповідей та презентацій англійською мовою.

Навчальний посібник «Іноземна мова за професійним спрямуванням (англійська)» спрямований на розвиток комунікативного мовлення студентів освітньо-кваліфікаційного рівня «бакалавр» напряму підготовки «Правознавство», засвоєння ними лексичних одиниць на матеріалі поданих текстів, формування навичок монологічного й діалогічного мовлення, підвищення рівня мовної та комунікативної компетенцій.

До навчального посібника включено тексти сучасних англомовних зарубіжних та вітчизняних видань. Тексти й завдання об'єднано у такі розділи суспільно-гуманітарної, лінгвокраїнознавчої та юридичної тематики: People & Society, Customs & Traditions, Law & Order, Reading for Pleasure, It's interesting to know....

Робота з текстами уніфікована та включає такі компоненти: активний словник, який передує кожному тексту; вправи на активізацію нової лексики, які сприяють закріпленню мовного матеріалу та поповненню лексичного запасу; вправи на переклад; вправи на перевірку розуміння мовного матеріалу, які сприяють вдосконаленню усного мовлення англійською мовою.

Окремі завдання складають вправи для розвитку підготовленого мовлення на основі тексту та непідготовленого мовлення за ситуацією, які сприятимуть спілкуванню студентів за програмною тематикою та поза її межами.

Додатки (Appendices) складаються з двох частин: Conversational Tools – розмовні фрази-кліше, які полегшать процес оформлення власної думки студентів, та Grammar Tools – граматичні правила на перетворення прямої мови в непряму, що спрощує процес переказу та реферування текстів.

FIRST YEAR AT UNIVERSITY

Olivia Johnston went to the School of Architecture at Kingston University in west London to find out what are the problems of first-year university students.

Jeremy Farrington (20): "I can't afford to live in the halls of residence so I commute from the other side of London every day. It takes me about two hours in the morning and two in the evening and costs me about £33 a week. But it's cheaper than living in a hall of residence. Halls cost about £50 a week at the cheapest.

You need to be very self-motivated in your first year. The tutors are very good. They give you great ideas and they're there for you if you need them. But at the end of the day, they can't force you to do the work.

You can't afford to sit back and not do the work for a week even if you don't feel up to it. It's not going to go away. It's very easy to fall behind. And once you do that, it's very difficult to get on top again."

Ben Wilcox (19): "I'm living in a hall of residence. In the hall there flats, with five people sharing a kitchen and a bathroom. The kitchen is probably the most social place. We're all busy people but we don't mind cooking for each other.

There's not a lot of one-to-one teaching. We have two tutorials a week but if you want to see your tutor for extra help you can arrange a tutorial any time. The lectures haven't been so important in our first year.

Money is a big problem for any university student. By the end of the first year every student will have spent too much money."

Martha Read (23): "I'm in my first year of architecture at Kingston but I've already done a degree in languages at Oxford. As a first year student in Oxford, I found the freedom amazing. Suddenly you're not living at home, and you can do exactly what you want.

In my first year at Oxford, I found that there was a tug between work and social life. Generally I found that social life won out. I only got into my work in my last year and started to enjoy it more. In my first year work seemed like a burden, probably because I always left it until the last minute.

I sometimes wish I had worked harder in my first year at Oxford. I think I would have enjoyed it more if I had. But then again, I did meet an awful lot of people."

Malin Paulsson (20): "My advice to school leavers about to start their first year at university? You shouldn't be lured by people who seem to be going out all the time and not doing any work. People do work, even if they don't seem to. You can get into the partying mode very easily when you first get here. The first weeks are a party, having fun and meeting people. But you do need to be responsible about your studies as well as having fun."

Tim Bell (Design tutor): "First-year students have to make a break from home, from a set of school friends they've probably been with for the last eight years. So it's always a bit stressful coming to a strange university. But on the whole I think most of them settle down and make friends.

The main problem is money. There's no way that the grant can possibly cover your expenses. It's very difficult to persuade your parents to give you an extra £25 a week, so many students have jobs. I think it's particularly stressful combining work and study for architecture students because they have to produce projects to a deadline every two weeks.

My advice to school leavers about to start university? Make sure you've got some savings and that you've got a very friendly bank manager!"

URBAN GRAFFITI: ART OR VANDALISM?

Discussing graffiti provokes a lot of opinions. The story of graffiti tells us a lot about social history, the hip-hop movements and artists in the USA.

Graffiti is nothing new. The concept is ancient. During the Second World War the phrase "Kilroy was here" appeared in a variety of places and countries. In 1969 one person made graffiti famous and inspired people to start "tagging" (writing their nickname in an artistic way). That person was a Greek teenager named Demetrius who lived on 183rd Street in New York. His nickname was Taki so his tag became TAKI 183. He then wrote it everywhere and people copied him. When buses and subway stopped in the main station in New York, dozens of writers would write their name on it. But it wasn't simply how many times people could write their name that was important but also the style they did it with.

Graffiti became a way of life – the adrenaline fear of being caught, standing in dangerous places while you graffiti, stealing the paint and creating something they were proud of. Graffiti style was massively influenced by the hip-hop culture that had started in the Bronx in the sixties. Hip-hop with its rapping, breakdancing, attitude and graffiti became a way to show anger and humour. The area and its inhabitants' lives were dominated by crime, drugs, gangs and unemployment. Street gangs began to write the name of their gang on walls in order to mark territorial boundaries.

Soon graffiti was spreading across America. In some cases graffiti was literally travelling at 100 miles an hour on trains. The reason railroad and subway trains were so popular for graffiti was so that it could be seen by so many people, from the poorest to the richest neighbourhoods.

Train companies invested in special cleaning chemicals so that graffiti could be removed quickly. However one graffiti artist in particular was not deterred — Lee Quinones decided if he couldn't paint trains, he'd paint his graffiti on handball courts instead.

No graffiti artists had ever been offered money for their work but one day Fred Brathwaite a graffiti artist himself, offered Quinones money for his murals.

Quinones and Brathwaite formed a graffiti mural group. Brathwaite painted a mural on a subway train as a tribute to Andy Warhol's Campbell's Soup cans picture. Soon wealthy gallery owners were noticing the graffiti artists' work. Brathwaite also teamed up with well-respected artist Keith Haring (died in 1990) who began doing a lot of his own subway graffiti with chalk. People liked it so much, the subway

companies didn't clean it off. Another graffiti artist and Puerto Rican friend of Haring named Jean-Michel Basquiat began to find fame too. Basquiat used to spray messages commenting on religion.

Many graffiti artists from the 1980s became rich. They were criticized for this by others who said that their motivation for graffiti shouldn't be money and that the whole point of graffiti is its "underground" style. There are also hundreds of graffiti events for artists now. These events promote unity between graffiti artists who are often rivals. Political graffiti and stencil graffiti are popular at the moment. "An eye for an eye leaves the whole world blind" was written on many buildings in New York, as a protest against America's attacks on Afghanistan.

Many states in the USA and different countries would like to stop graffiti. In Pittsburgh USA, there is a proposed law to ban the sale of marker pens to people under 18. Other countries are very harsh. Singapore has just one wall where graffiti can be written (even then, some of it is censored). The city has a caning-for-graffiti rule. In 1994 American teenager Michael Fay spray painted car and was sentenced to a flogging.

BODY ART

We have been tattooing and piercing our bodies for thousands of years, but never has the practice of body modification been as popular as it is today. Tattoos can be found on everyone from Robbie Williams to Angelina Jolie, and even Princess Anne of England's daughter has her tongue pierced.

Tattooing can be found the world over, though its style and associated meaning vary dramatically. Tattooing has long featured in the cultures of the Japanese, Polynesians and Native Americans. The practices of the Maoris of New Zealand provide a striking example of tattooing. They are well known for the elaborate patterns with which they traditionally decorated their faces. Integration with white settlers led to a decline in this custom, but it is now regaining popularity amongst young Maoris.

Body art all over the world...

Native American Indians and the Inuit are known to have pierced lower lip, and today this practice is found in tribes across Africa and South America. A long cane is often pushed through the skin around the mouth or nose as decoration. The Sara tribe of central Africa, for example, traditionally pierce and then stretch their lips with saucerlike discs. Nose piercing is common in India, South America and Africa, as is ear piercing through the ear lobe is gradually stretched to create a visible hole. This is more and more common in the West, where it is sometimes referred to as a "flesh tunnel."

In non-Western cultures, tattooing and piercing has recently declined as these societies try to "catch up" with the West. Paradoxically, in the West their popularity is ever increasing. Until recently, body art in our culture was mainly found in groups such as sailors and convicts, or those wanting to rebel against society, like the punks of the 1970s. Over the last decade body art has moved into the mainstream, and it is increasingly socially acceptable.

...and all over the body

Just about every part of the body can be pierced or tattooed. In the West, facial piercings are popular, (especially through the eyebrow, lip, and tongue), as are navel piercings. David Beckham, the famous British footballer, recently sparked a craze for tattoos in foreign languages when he had his wife's name, Victoria, tattooed on his forearm in Hindi. Polynesian style tattoos of large swirling blocks of colour are currently fashionable with men, while women still tend to favour smaller, less visible tattoos.

Motivations for body art

People use body art for a range of reasons. In the past tattoos have been used as a mark of social status, to ward off demons and ill health, or to mark an important event in one's life. They have also been used as means of identifying and pushing convicts, slaves and outcasts. However, these days most people use body art simply as decoration. It has become a fashion statement, in the same way that an item of clothing or hairstyle might be.

Body modification in the extreme

Body modification can be used as a sign of rebellion and individuality, to distance oneself from society. As tattooing and piercing become increasingly common however, some people are resorting to more extreme methods of body modification to stand out from the crowd. "Body branding," for example, is a dramatic (and dangerous) practice which is gaining in popularity. It involves searing the skin with red-hot metal, in some shape or pattern, to leave a permanent scar. Branding cannot be used for intricate designs, as tattooing can, and instead it leaves a relatively simple raised shape on the skin. Branding parlours are rare though, so frighteningly many choose to brand themselves, despite the obvious risks of infection.

Implanting is another extreme way in which people alter their body's appearance. Somewhat similar to body piercing, it involves the painful sounding insertion of metal objects under the skin. Burmese tribes have long carried out similar practices, placing what they believe to be magical protective objects under the skin. Again the risk of infection and rejection of the object by the body is high, especially as although this cutting of the skin is a form of surgery, it is not generally carried out by qualified doctors or anaesthetists. One example of implanting is the insertion of horn of the forehead, giving a "devil-like" appearance.

Body art is here to stay

It seems unlikely that branding and implanting will ever become as popular or mainstream as tattooing and piercing. Branding does not allow the breadth of statement that tattooing does, and implanting is not for faint-hearted. But fifty years ago, who would have thought that businessmen would go to work hiding piercings under their suits, or that kids would be asking their parents for tattoos for their sixteenth birthday? Whether branding and implanting will take off or not, one thing is certain – body art, in one form or another, is here to stay.

TELEVISION: THE BEGINNING OF THE END?

The rise of reality TV

A glance at today's TV listings shows that there has been a major change in television viewing habits. All the British channels – and many foreign ones – are dominated by something collectively called "reality TV". We have watched ordinary people trying to pass a driving test, going on a date with a stranger, simply doing their own job (being a vet, working in an airport, or on a cruise ship), doing a job swap, trying to survive some terrible endurance test such as living in the jungle or on an inhospitable Scottish island, or surviving life in a simulated earlier period of history. And while doing all of these things, we have watched them like fish a tank.

In many of the recent shows, a group of ordinary people are put together in a competitive situation and either the group members themselves, or the millions of viewers, decide – over a period of time – which person is eliminated each week until there is one eventual winner.

Survival of the fittest

One of the most internationally successful formats has been $Big\ Brother-a$ group of ordinary people living in a house for several months. There has also been a celebrity version of this plus desert island variations, Survivor and Shipwrecked. In the most bizarre version, called $Temptation\ Island$, couples volunteer to be subjected to attempts to break up their relationships with their partners.

In addition, Britain has had *Popstars* (a talent show where thousands of hopeful young singers are reduced to just five), Pop Idol (the same thing but looking for one solo singer) and *Soapstars* where TV viewers selected a group of unknown people to be a new "family" in the popular British soap, *Emmerdale*.

You are the weakest link, goodbye!

The *Weakest Link* general knowledge quiz show became a massive hit in many countries in the world partly because the format was based on the rudeness of the presenter. Competitors have to vote each other off the quiz for being the weakest team player.

Even stand-up comedy clubs have "going shows" where audience members bang a gong to send a comedian off the stage for not being funny enough.

The cult of the nobody

So what have they all got in common apart from the fact that none of the people involved in these programmes own Equity cards? The interesting thing, from a sociological viewpoint, is that all of these programmes seem to be looking for, celebrating, or often publicly mocking losers. Millions of people turn on their TV sets with a macabre curiosity to see how the week's loser is going to take the bad news. The camera goes in close. Will the loser cry? Will the loser get angry? Will the loser go mad? What will happen afterwards to the loser and the loser's family or partner? The tabloids write about these people by first name as if they are members of our own families. Within days of a loser being eliminated or having failed a task, we read that "Helen is dumped by her ex-boyfriend", "Jason is seen drunk at a famous nightclub", "Max's girlfriend sells her story to the newspapers", etc. Society seems to be desperate for celebrities. We don't have enough famous people who are good at acting, singing, politics, etc, so a whole new breed of nobodies have to become somebodies for a few weeks. In addition, it is often the more grotesque, psychologically flawed people who allow themselves to get be chosen. They appear in the celebrity gossip magazines a few times and usually end up lonely and rejected, dissatisfied with the lives they had before the programme, but incapable of working in television or using any of the skills which they needed for their reality programme (e.g. being able to kill and eat a rat to survive on a desert island) in any other area of life. It's not even good news for the winners.

Pop stars by elimination

The manufactured pop group "Hear' Say", formed from a nation-wide pop competition, lost their popularity after a year when one member left, selling her story of bitter fights in the group to the newspapers.

But on the whole, all of these programmes are about money and manipulation. In the case of Pop Idol, people were asked to vote by phone once a week to eliminate one of the final ten solo singers over a period of nine weeks. The prize was a lucrative recording contract and the opportunity to be managed by some of the top people in the music business. However, two of the judges worked for the management company.

The company received money from all the phone calls when people voted and the management company received a massive percentage of the profits from the winner's record sales and concerts. Despite the fact there was only going to be one winner (the "pop idol"), they decided quite early on to offer a recording contract to the person who came second as well. He also was sent on a luxury holiday and released his record and video a few weeks after the winner. In fact over eight million

people wasted their money by voting by phone since there had already been a decision to create, in effect, two winners.

Celebrating losers: the new religion

Throughout history, people have always enjoyed the thrill of finding a winner. However, the whole focus in the new breed of reality TV shows has shifted onto the many losers rather than onto the one winner. It not only shows people's personal greed, it also shows the depths to themselves a few minutes of TV fame. In addition, new psychological research suggests that worship of celebrities by the public has begun to take the place of religion in many people's lives. Our worship of celebrities does indeed turn them into the most powerful people on this planet – the equivalent of gods in our midst. Now *that's* scary!

WHAT ARE THE MOST COMMON SUPERSTITIONS IN BRITAIN?

There are many superstitions in Britain, but one of the most widely-held is that it is unlucky to walk under a ladder – even if it means stepping off the pavement into a busy street!

If you must pass under a ladder you can avoid bad luck by <u>crossing your fingers and keeping them crossed until you've seen a dog</u>. Alternatively, you must lick your finger and make a cross on the toe of your shoe, and not look at the shoe until the mark has dried.

Another common superstition is that it is unlucky to open an umbrella in the house – it will either bring misfortune to the person that opened it or to the household. Anyone opening an umbrella in fine weather is unpopular, as it inevitably brings rain!

The number 13 is said to be unlucky for some, and when the 13th day of the month falls on a Friday, <u>anyone wishing to avoid an inauspicious event had better stay indoors.</u>

The worst misfortune that can befall you is incurred by breaking a mirror, as it brings seven years of bad luck! The superstition is supposed to have originated in ancient times, when mirrors were considered to be tools of the gods.

Black cats are generally considered lucky in Britain, even though they are associated with witchcraft – a witch's animal-familiar is usually a black cat. It is especially lucky if a black cat crosses your path – although in America the exact opposite belief prevails.

Finally, a commonly-held superstition is that of touching wood for luck. This measure is most often taken <u>if you have said something is tempting fate</u>, such as "my car has never broken down – touch wood!"

WEDDING SUPERSTITIONS

In England the wedding preparations, ceremony and feast have all become loaded with ritual practices to ward off evil and bless the marriage with fortune and fertility.

The choice of date is important. May is traditionally unlucky for weddings and many modern couples marry between Easter and late May, the practice much encouraged by tax rebates. The tradition that the bride's parents should pay for the wedding dates back from two or three centuries ago, when wealthy families would pay an eligible bachelor to take an unmarried daughter off their hands in exchange for a large dowry. At most formal weddings brides still get married in virginal white – many other colours are considered unlucky.

A bride will also ensure that her wedding outfit includes "something old, something new, something borrowed, something blue". "Old" maintains her link with the past; "new" symbolizes the future; "borrowed" gives her a link with the present; and "blue" symbolizes her purity.

Even a modern bride will observe the taboos about wearing her dress before the ceremony. The groom mustn't see her in it until she enters the church. The veil should be put on for the first time as she leaves for the church. It's a lucky omen if the bride should see a chimney sweep on her way to church. Sometimes a sweep is paid to attend the ceremony and kiss the bride – a relic of the old idea that soot and ashes are symbols of fertility.

After the ceremony, the couple is showered with the confetti – to bless the marriage with fertility.

One old customs was for the bride and sometimes the groom to negotiate some obstacle as they left the church - guests would impede them with ropes of flowers, for example, or with sticks that had to be jumped over.

After that the bride is faced with the feast. The most important item is the wedding cake, whose richness symbolizes fertility, just as it has done since Roman times. Today, the first slice is cut by the bride to ensure a fruitful marriage.

In Chicago in 1992 a man jumped off the roof of 26-storey building. As he fell past the 14th floor, someone shot a bullet out of a window which hit him in the head, killing him instantly.

A window cleaning company had put it up to catch their employees if they fell while cleaning windows. If the man had not been shot, the net would have caught him and he would not have died.

What now is the crime?

The police thought they might be investigating a murder, so they tried to find out who had fired the gun. An old man and his wife had been having an argument in the apartment on the 14th floor. While they were fighting, the man took a gun from his desk and shot at his wife. The bullet missed her and went out of the window where it hit the man who had jumped from the roof. So presumably the old man could be charged with the murder of the man who died, as well as the attempted murder of his wife.

However, the old man claimed that he was innocent. He said that he thought the gun was empty and that he often threatened his wife with an empty gun when they were arguing. The police thought this sounded unlikely, but his wife confirmed that this was true. They often fought and he often threatened to kill her, but both of them knew that the gun was never loaded. Neither of them could understand how the bullet had been in the gun.

After some enquiries, the police decided that the old couple's teenage son had probably loaded the gun. The boy urgently needed some money and he knew he would inherit a large sum of money when his mother died. He knew about his father's habit of firing an empty gun at his mother, so he bought some bullets, loaded the gun and waited for his father to shoot his mother.

However, his parents didn't have an argument for a long time and the boy became more and more depressed about money. Eventually he decided to commit suicide. He went to the roof of the building where his parents lived and jumped off. As he fell past the 14th floor, someone shot a bullet out of a window which hit him in the head, killing him instantly.

On March 23, 1994 a medical examiner looked at the body of Ronald Opus and concluded that he had died from a shotgun wound to the head. Ronald had jumped from the top of a 10-storey building with the intention of committing suicide.

He had left a note behind before he jumped and as he fell past the ninth floor, a bullet was fired through the window, killing him instantly. Unknown to everyone, a safety net had been put up just below the eighth floor for some building workers so Ronald would never have been able to kill himself. Usually, when someone succeeds at committing suicide, regardless of changing circumstances, their death is still defined as suicide. Because Ronald was shot during a suicide attempt, and probably would have been saved by the safety net, the medical examiner felt he had a murder on his hands.

An old man and his wife lived on the ninth floor where the gun had been fired. The man had been threatening his wife during an argument. He was so mad, he pulled the trigger but missed his wife and hit Ronald instead. Even though he tried to kill his wife, he still killed someone else in the attempt so he's guilty of murdering Ronald. The man and his wife insisted they thought the gun was unloaded. It was a habit to threaten his wife with the gun and he had no intention of murdering her. If the gun was accidentally loaded, then the killing was an accident.

More investigating turned up a witness who saw the couple's son load the shotgun several weeks before the accident. Apparently, the old lady had cut off her son's money. So the son, who knew about his dad's bad habit of threatening Mom with the gun, loaded the gun so his dad would shoot her. He was guilty of murdering Ronald even though he didn't pull the trigger.

But get this...

The son was actually Ronald Opus. He had become depressed cuz his attempt to cause his mom's murder wasn"t working out. When he jumped off the 10-storey building, Ronald had actually murdered himself. The medical examiner considered the death a suicide and closed the case.

WHAT IS THE DIFFERENCE BETWEEN A JUDGE, A BARRISTER AND A SOLICITOR?

A judge is a crucial figure in the trial system. He or she supervises the conduct of the trial and passes sentence on those who have been convicted. <u>Judges are normally appointed from practising barristers (advocates in Scotland) or solicitors and must have at least 10 years professional standing.</u>

The kind of judge chosen to preside over a case in court depends on its seriousness and complexity. Very serious offences are tried on indictment only by the Crown Court. The Crown Court sits in about 94 centres in England and Wales, many of them consisting of several courtrooms.

Appeals from the Crown Court are made to the Court of Appeal. A further appeal from the Court of Appeal to the House of Lords can be brought if a point of law of general public importance is considered to be involved.

Most minor civil cases are dealt with by the county courts, of which there are about 270. Cases are heard by circuit judges or district judges. Magistrates' courts are the lowest tier of the criminal justice system. Justice is delivered not by professional judges or lawyers, but by appointed representatives of the community, called Magistrates. Their main job is to deliver "summary justice" to people charged with less serious crimes. They refer grave offences to the Crown Court.

The legal profession in Britain is divided into two branches: barristers (advocates in Scotland) and solicitors.

Solicitors undertake legal business for individual and corporate clients, while barristers advise on legal problems submitted through solicitors and present cases in the higher courts. Certain functions are common to both – for example, the presentation of cases in the lower courts.

Barristers must pass professional examinations before being called to the Bar (Barristers are known collectively as the Bar), and they must then serve an apprenticeship or "pupillage" with a qualified barrister for one year.

Solicitors must also pass professional examinations and serve a two-year period of apprenticeship called "articles" in a solicitor's office. Once qualified in this way, a newly admitted solicitor is supervised for three years.

3-hour girl snatched from hospital

A baby just three hours old was snatched from her mother's hospital bedside by an intruder dressed as a nurse.

Tania Godfrey was still groggy from an anaesthetic when the unknown woman walked off with her tiny daughter, Karli.

The distraught mother, who had given birth by Caesarean section on her 30th birthday, managed to raise the alarm with the help of another mother in the ward at Basildon General Hospital, Essex.

A staff nurse gave chase through the hospital corridors, but the woman escaped. A massive police hunt was in progress to find baby Karli as fears grew for her health. Doctors warned that she urgently needed to be fed and kept warm.

The intruder, possibly wearing a blond wig, breached the hospital's security by strolling into Willow Ward and removing 6lb 15oz Karli from a cot at her mother's side. The stranger was described as being aged between 25 and 30, about 5ft 6in and wearing a three-quarter length coat. It is believed the same woman was seen earlier in the day wandering around maternity wing and was ordered to leave.

Sue Jennings, chief executive of Basildon General Hospital, said there were 13 video cameras monitoring the hospital. All film footage was now being examined by police.

Man snapped neighbour having sex

A former chairman of a residents' association, who photographed a 20-year-old neighbour undressing and having sex, was trying to gather evidence of a "public nuisance", his 76-year-old mother claimed.

James Brown, 43, used a telescope to spy on Melissa Campbell and poked a camera through his venetian blinds to take 36 pictures of her in various state of undress.

In some of the photographs the Australian university student was making love to her boyfriend, Stirling Sheriff Court was told.

Brown, unemployed, was fined £500 and ordered to pay Miss Campbell £300 in compensation after admitting a breach of the peace by taking pictures of her without her knowledge.

Sheriff Marcus Brown told him his behaviour was despicable. "Invasion of privacy, particularly in a bedroom occupied by a young lady, cannot and will not be tolerated", he said.

Miss Campbell said she was shocked when police told her she had been photographed in the nude.

Rapist leaves victim scarred for life

A sex attacker excited by extreme violence has left his latest victim physically and mentally scarred for life.

The 42-year-old woman, who was beaten senseless with a brick and raped in her west London front garden by Lee McGregor, has had to move. "The memories of her front door were so bad she resorted to leaving the house by the back window," Gino Connor, prosecuting, said.

He said the victim was still receiving hospital treatment for facial and other injuries seven months after the attack. McGregor, 30, has been released from a 18-month sentence for raping and beating up a woman when he leapt on his latest victim. "The more violent he was, the more excited he became," said Mr Connor.

McGregor, of Fulham, admitted rape and causing grievous bodily harm with intent. He was remanded in custody for reports.

TRAFFICKING IN PERSONS

Speaking about trafficking in persons we can't but mention that it's become the one of the world wide problems connected with the violation of human rights.

The earliest understanding of "trafficking" comes from United Nations instruments. The term "traffic" was first used to refer to the so-called "white slave trade" in women around 1900. At that time "traffic" meant the movement of women

for an immoral purpose, for example, prostitution. Traffic in women was seen as related to slavery, but also to closely linked to prostitution. Since that time trafficking in persons, particularly in women, has been often confused with prostitution and is still seen in the anti-trafficking activism of some individuals, organisations and governments today. So, at different times in history, the then prevailing concept of trafficking has ignored the human rights of trafficked persons; been used by moralists to dictate to women in prostitution; been used by governments to restrict the movements of women. However, migrating for sex work is not trafficking.

Under the law term "trafficking" we understand all acts and attempted acts involved in the recruitment, transportation within or across borders, purchase, sale, transfer, receipt or harbouring of a person involving the use of deception, coercion (including the use or threat of force or the abuse of authority) or debt bondage for the purpose of placing or holding such person, whether for pay or not, in involuntary servitude (domestic, sexual or reproductive), in forced of bonded labour, or in slavery-like conditions, in a community other than the one in which such person lived at the time of the original deception, coercion or debt bondage.

In other words, trafficking in persons is intended to include a range of cases where human beings are exploited by organized crime groups, where there is an element of duress involved and a transnational aspect, such as the movement of people across borders or their exploitation within a country by a transnational organized crime group; trafficking is the recruitment, transportation, transfer, harbouring or receipt of persons by improper means, such as force, abduction, fraud or coercion, for an improper purpose, like forced or coerced labour, servitude, slavery or sexual exploitation.

Solving the problem of trafficking in persons we should not forget about human rights. Every state has obligations to recognize and protect the human rights of all persons in conformity with the Universal Declaration of Human Rights and other rights of the persons within its territorial boundaries, as well as to enable such persons to realize those rights and to ensure the realization of rights possible by each person. It is necessary to understand, that trafficked persons should not be treated as criminals but as victims of crimes who have suffered serious human rights abuses.

Practice shows that current policies in the majority of states have the effect of deterring trafficked persons from reporting to the authorities, as reporting may result in arrest, detention or expulsion. In order to obtain successful prosecutions of traffickers, states must implement policies and laws to allay the fear most trafficked persons have towards authority and law and must further provide incentives to encourage trafficked persons to seek help, report to the authorities and, if they wish act as witnesses. The names of trafficked persons should not be recorded in any court or other public documents, nor should they be released to the press or members of the public, including family members, without the consent of the trafficked persons.

Being lawyers we should fight against this phenomena and do our best to suppress it. Using the legal background, for example the "Protocol to prevent, suppress and punish trafficking in persons" (United Nations, 2000), we can't but take part in the international cooperation against such trafficking.

Essentially, this Protocol is intended to prevent and combat trafficking in persons and to facilitate the return of its victims. It provides for criminal offences, control and cooperation measures against traffickers. It also provides some measures to protect and assist the victims. Some issues remain open with respect to the application of the Protocol to purely domestic activities (e.g. movement of victims within a country), which support international trafficking.

Law enforcement agencies of countries that ratify this Protocol would be required to cooperate with such things as the identification of offenders and trafficked persons, sharing information about the methods of offenders and the training of investigators, enforcement and victim support personnel. Countries would also be required to implement security and border controls to detect and prevent trafficking. These include strengthening their own border controls, imposing requirements on commercial carriers to check passports and visas, setting standards for the technical quality of passports and other travel documents and cooperation in establishing the validity of their own documents when used abroad.

THE INTERNET

The Internet, a global computer network which embraces millions of users all over the world, began in the United States in 1969 as a military experiment. It was designed to survive a nuclear war. Information sent over the Internet takes the shortest path available from one computer to another. Because of this, any two computers on the Internet will be able to stay in touch with each other as long as there is a single to this technology, if some computers on the network are knocked out (by nuclear explosion, for example), information will just route around them. One such packet-switching network which has already survived a war is the Iraq computer network which was not knocked out during the Gulf War.

Most of the Internet host computers (more than 50%) are in the United States, while the rest are located in more than 100 other countries. Although the number of host computers can be counted fairly accurately, nobody knows exactly how many people use the Internet, there are millions worldwide, and their number is growing by thousands each month.

The most popular Internet service is e-mail. Most of the people, who have access to the Internet, use the network only for sending and receiving e-mail messages. However, other popular services are available on the Internet: reading Usenet News, using the World-Wide-Web, telnet, FTP, and Gopher.

In many developing countries the Internet may provide businessmen with a reliable alternative to the expensive and unreliable telecommunications systems of these countries. Commercial users can communicate cheaply over the Internet with the rest of the world. When they send e-mail messages, they only have to pay for phone calls to their local service providers, not for calls across their countries or around the world. But who actually pays for sending e-mail messages over the Internet long distances, around the world? The answer is very simple: users pay their service provider a monthly or hourly fee. Part of this fee goes towards its costs to connect to a larger service provider, and part of this fee received by the larger provider goes to cover its cost of running a worldwide network of wires and wireless stations.

But saving money is only the first step. If people see that they can make money from the Internet, commercial use of this network will drastically increase. For example, some western architecture companies and garment centres already transmit their basic design and concepts over the Internet into China, where they are reworked and refined by skilled – but inexpensive – Chinese computer-aided-design specialists.

However, some problems remain. The most important is security. When you send an e-mail message to somebody, this message can travel through many different networks and computers. The data is constantly being directed towards its destination by special computers called routers. However, because of this, it is possible to get into any of the computers along the route, intercept and even change the data being sent over the Internet. In spite of the fact that there are many good encoding programs available, nearly all the information being sent over the Internet is transmitted without any form of encoding, i.e. "in the clear". But when it becomes necessary to send important information over the network, these encoding programs may be useful. Some American banks and companies even conduct transactions over the Internet. However, there are still both commercial and technical problems which will take time to be resolved.

Cybercrime is an increasing problem of global proportions. How can national law stop people who commit fraud, spread racism, steal credit card numbers or sell child pornography worldwide, nonstop and anonymously?

Organized crime uses the Internet for human trafficking and committing economic crimes.

On top of that, there is a real danger of a terrorist attack on computer systems that run airports and financial institutions.

YOUNG OFFENDERS

The problem of young offenders is very difficult.

Some experts say prosecuting juveniles as adults is justified because these offenders commit violent crimes. But others say young offenders may serve harsh prison terms for nonviolent offenses.

INTERPOL

Interpol is the world's largest international police organization with 181 member countries. Interpol was created in 1923. It facilitates international police cooperation, and assists all organizations who combat international crime.

Since 1989, the General Secretariat has been located in Lyon, France. Interpol operates 24 hours a day, 365 days a year. It has four official languages: English, French, Spanish and Arabic.

Interpol also has five regional bureaus: in Harare, Abidjan, Nairobi, Buenos Aires and San Salvador.

Each member country has a National Central Bureau (NCB) staffed by national law enforcement officers.

Ukraine was admitted to the INTERPOL in 1992. National Central Bureau of Interpol in Ukraine is a department of the Ministry of Internal Affairs of Ukraine. The main mission of the NCB of Interpol in Ukraine is the coordination of the law enforcement agencies of the country in the transnational crime fighting.

NCB comprises several units, such as a monitoring unit, financial and informational departments, an international organized crime unit, an illegal immigration and human trade unit, and a secretariat. The staff of NCB consists of 53 police officers and 3 civilians.

Ukrainian officers are posted abroad to: Israel, Poland, Russia, Hungary, Romania, USA, and Germany. Foreign officers are posted to Kiev from: Poland, Germany, USA, Austria, Great Britain, Hungary, Slovakia, and Republic of Belarus.

FBI

Tomorrow I die. Tomorrow I die, and today I want to tell the world what happened and thus perhaps free my soul from the horrible weight which lies upon it. But listen! Listen, and you shall hear how I have been destroyed.

When I was a child I had a natural goodness of soul which led me to love animals — all kinds of animals, but especially those animals we call pets, animals which have learned to live with men and share their homes with them. There is something in the love of these animals which speaks directly to the heart of the man who has learned from experience how uncertain and changeable is the love of other men.

I was quite young when I married. You will understand the joy I felt to find that my wife shared with me my love for animals. Quickly she got for us several pets of the most likeable kind. We had birds, some goldfish, a fine dog, and a cat.

The cat was a beautiful animal, of unusually large size, and entirely black. I named the cat Pluto, and it was a pet I liked best. I alone fed it, and it followed me all around the house. It was even with difficulty that I stopped it from following me through the streets.

Our friendship lasted, in this manner, for several years, during which, however, my own character became greatly changed. I began to drink too much wine and other strong drinks. As the days passed I became less loving in my manner; I became quick to anger; I forgot how to smile and laugh. My wife – yes, and my pets, too, all except the cat – were made to feel the change in my character.

One night I came home quite late from the inn, where I now spent more time drinking. Walking with uncertain step, I made my way with effort into the house. As I entered I saw – that Pluto, the cat, was trying to stay out of my way, to avoid me. This action, by an animal which I had thought still loved me, made me angry beyond reason. My soul seemed to fly from my body. I took a small knife out of my coat and opened it. Then I took the poor animal by the neck and with one quick movement I cut out one of its fear-filled eyes!

Slowly the cat got well. The hole where its eye had been was not a pretty thing to look at, it is true; but the cat no longer appeared to suffer any pain. As might be expected, however, it ran from me in fear whenever I came near. Why should it not run? Yet this did not fail to anger me. I felt growing inside myself a new feeling. Who has not, a hundred times, found himself doing wrong, doing some evil thing for no other reason than because he knows he should not? Are not we humans at all times pushed, ever driven in some unknown way to break the law just because we understand it to be the law?

One day, in cold blood, I tied a strong rope around the cat's neck, and taking it down into cellar under the house I hung it from one of the wood beams above my head. I hung it there until it was dead. I hung it because I knew it had loved me, because I felt it had given me no reason to hurt it, because I knew that my doing so was a wrong so great, a sin so deadly that it would place my soul forever outside the reach of the love of God!

That same night, as I lay sleeping, I heard through my open window the cries of our neighbours. I jumped from my bed and found that the entire house was filled with fire. It was only with great difficulty that my wife and I escaped. And when we were out of the house, all we could do was stand and watch it burn to the ground. I thought of the cat as I watched it burn, the cat whose dead body I had left hanging in

the cellar. It seemed almost that the cat had mysterious way caused the house to burn so that it could make me pay for my evil act, so that it could take revenge upon me.

Months went by, and I could not drive the thought of the cat out of my mind. One night I sat in the inn, drinking, as usual. In the corner I saw a dark object that I had not seen before. I went over to see what it could be. It was a cat, a cat almost exactly like Pluto. I touched it with my hand and petted it, passing my hand slowly along its back. The cat rose and pushed its back against my hand.

Suddenly I realised that I wanted the cat. I offered to buy it from the innkeeper but he claimed he had never seen the animal before. As I left the inn, it followed me, and I allowed it to do so. It soon became a pet of both my wife and myself.

The morning after I brought it home, however, I discovered that this cat, like Pluto, had only one eye. How was it possible that I had not noticed this the night before? This fact only made my wife love the cat more. But I, myself, found a feeling of dislike growing in me. My growing dislike of the animal only seemed to increase its love for me. It followed me, followed me everywhere, always. When I sat, it lay down under my chair. When I stood up it got between my feet and nearly made me fall. Whenever I went, it was always there. At night I dreamed of it. And I began to hate the cat!

One day my wife called to me from the cellar of the old building where we were now forced to live. As I went down the stairs, the cat, following me as always, ran under my feet and nearly threw me down.

In sudden anger, I took a knife and struck wildly the cat. Quickly my wife put out her hand and stopped my arm. This only increased my anger and, without thinking, I turned and put the knife's point deep into her heart! She fell to the floor and died without a sound.

I spent a few moments looking for the cat, but it was gone. And I had other things to do, for I knew I must do something with the body, and quickly. Suddenly I noted a place in the wall of the cellar where stones had been added to the wall to cover an old fireplace which was no longer wanted. The walls were not very strongly built, and I found I could easily take down those stones. Behind them there was, as I knew there must be, a hole just big enough to hold the body. With much effort I put the body in and carefully put the stones back in their place. I was pleased to see that it was quite impossible for anyone to know that a single stone had been moved.

Days passed. Still there was no cat. A few people came and asked bout my wife; but I answered them easily. Then one day several officers of the police came. Certain that they could find nothing, I asked them in and went with them as they searched.

Finally they searched the cellar from end to end. I watched them quietly, and, as I expected, they noticed nothing. But as they started up the stairs again, I felt myself driven by some unknown inner force to let them know, that I had won the battle.

"The walls of this building," I said "are very strongly built; it is a fine old house." And as I spoke I struck with my stick that very place in he wall behind which was the body of my wife. Immediately I felt a cold feeling up and down my back as we heard coming out of the wall itself a horrible cry.

For one short moment the officers stood looking at each other. Then quickly they began to pick at the stones, and in a short time they saw before them the body of my wife, black with dry blood and smelling of decay. On the body's head, its one eye filled with fire, its wide open mouth the colour of blood, sat the cat, crying out its revenge!

Well, Poe began to drink. I was about to say that he learned how to drink; the trouble is that he didn't. In those early days of the young United States life was rougher than it is today. Most men did not think badly of another man just because he drank; but if the man didn't know how to drink - if he drank too much or at the wrong time of the day or in the wrong place – then men felt that drinking was wrong. Poe was one who didn't know how. Oh, we mustn't think that Poe drank all the time. If that had been true he could not have written anything. No, there were long periods when Poe didn't drink at all; but there were other periods when he felt he couldn't continue to exist without drinking. Thus, Poe created trouble for himself. This is not the only example of how Poe did the wrong thing, knowing that it was the wrong thing. Apparently it was a part of his character to do so. Poe recognised this problem in himself. In his story The Black Cat, he wrote: "Who has not, a hundred times, found himself doing wrong, doing some evil thing for no other reason than because he knows he should not? Are not we humans at all times pushed, even driven in some unknown way to break the law just because we understand it to be the law?" (A Talk by Professor F. Cowles Strickland)

mind will be a whirl with scrutiny... Nice eyes. Check. Just the right height. Check. Oh, wait a minute! Kind of chunky. Black mark. Aargh! Polyester shirt! Two black marks!

При перетворенні прямої мови на непряму утворюється складнопідрядне речення з підрядним додатковим реченням із сполучником **that**, або без нього:

He says, "Lessons begin at eight".

He says that lessons begin at eight.

He says lessons begin at eight.

Як і в українській мові, особові й присвійні займенники при заміні прямої мови непрямою змінюються або залишаються без змін залежно від змісту: She says, "I'll work in **my** village".

She says that **she**'ll work in **her** village.

She says, "**They** will work in **their** village". She says that **they** will work in **their** village.

Якщо в словах автора присудок виражено дієсловом **to say** з додатком, що позначає особу, до якої звернено пряму мову (цей додаток вживається з прийменником **to**), то перед непрямою мовою **to say** зазвичай замінюється дієсловом **to tell**, після якого додаток вживається без прийменника. Але якщо дієслово **to say** у словах автора вжито без додатка, то воно залишається і перед непрямою мовою:

He **says to me**, "I know it." He **tells me** that he knows it.

He **says**, "I know it." He **says** that he knows it.

Якщо в словах автора дієслово-присудок виражає минулу дію, то при перетворенні прямої мови на непряму час дієслова змінюється відповідно до правил узгодження часів, а саме:

a) Present Indefinite змінюється на Past Indefinite: He said, "I **know** it."

He said that he **knew** it.

- b) Present Continuous змінюється на Past Continuous: "I am working," she said. She said that she was working.
 - c) Present Perfect змінюється на Past Perfect:

He said, "I have translated the text."
He said that he had translated the text.

- d) Present Perfect Continuous змінюється на Past Perfect Continuous: "I have been working since 9 o'clock," she said. She said that she had been working since 9 o'clock.
 - e) Past Indefinite змінюється на Past Perfect:

He said, "I **saw** her there." He said that he **had seen** her there.

f) Past continuous змінюється на Past Perfect Continuous: She said, "I was reading."

She said that she had been reading.

Але якщо час дії точно зазначено, Past Indefinite і Past Continuous залишаються без змін:

"I saw her in May," he said.

He said that he saw her in May.

She said, "We were listening to the radio at 7 o'clock." She said that they were listening to the radio at 7 o'clock.

Past Perfect i Past Perfect Continuous залишаються без змін: The students said, "We **had finished** our work by 7 o'clock." The students said that they **had finished** their work by 7 o'clock.

"At that time I **had been working** at the plant for three years," he said. He said that at that time he **had been working** at the plant for three years.

Усі форми майбутнього часу – Future Indefinite, Future Continuous, Future Perfect замінюються відповідними формами Future in the Past:

He said, "I'll go there." He said that he would go there.

She said, "I'll have read the book by Monday." She said that she would have read the book by Monday.

He said, "I'll be working this summer."
He said that he would be working that summer.

При перетворенні прямої мови на непряму вказівні займенники та деякі обставини часу і місця змінюються так:

Пряма мова	Непряма мова
This	that
These	those
Now	then
Here	there
Today	that day
yesterday	the day before
the day before yesterday	two days before
tomorrow	the next day
the day after tomorrow	two days later
Ago	before
Next	the next

He said, "I live in **this** house."

He said that he lived in that house.

"I'll go there **tomorrow**," he said. He said that he'd go there **the next day**.

Примітка. Якщо в прямій мові зазначено точну дату The boy said, "I **was born** in 1999." The boy said that he **was born** in 1999.

Питальні речення, відтворені непрямою мовою, називаються непрямими запитаннями (indirect questions). Непрямі запитання мають структуру розповідного речення: в них прямий порядок слів (присудок ставиться після підмета), у Present і Past Indefinite допоміжне дієслово **to do** не вживається.

При перетворенні запитань з прямої мови на непряму дієслово **to say** у словах автора замінюється дієсловом **to ask** або одним з його синонімів.

При перетворенні прямої мови на непряму загальне запитання замінюється підрядним реченням, що з'єднується з головним за допомогою сполучників **if** або **whether:**

"**Do you know** the boy?" I asked him. I asked him **if he knew** the boy.

"Have you a pencil?" he asked me. (Greene) He asked me if I had a pencil.

При відтворенні непрямою мовою спеціальних запитань питальні слова (займенники і прислівники) стають сполучними словами:

"Why didn't you come?" he said to me.

He asked me why I hadn't come.

"Where have you been?" she asked him.

She asked him where he had been.

При перетворенні в непряму мову наказових речень наказовий спосіб дієслова прямої мови замінюється інфінітивом. У заперечній формі перед інфінітивом ставиться частка **not.**

Дієслово to say у словах автора замінюється дієсловами to ask, to tell, to order або їх синонімами:

"Wait a while longer," he said to me. (Greene) He asked me to wait a while longer.

I said to her, "**Don't go out**." (Brand) I asked her **not to go out**.

INDIRECT SPEECH IN BRIEF

When a declarative sentence is changed from direct into indirect speech, it becomes an object clause introduced by the conjunction **that** which is often omitted.

Personal and possessive pronouns are shifted or remain unchanged according to sense.

If the reporting verb **to say** has an object (with the preposition **to**) denoting the person addressed, the verb **to say** is usually replaced by the verb **to tell** after which the object is used without a preposition. When the person addressed is not indicated, the verb **to say** remains before the indirect speech.

If the reporting verb denotes a past action, tenses of the verb of the direct speech are changed according to the rules of the sequence of tenses.

In indirect questions there is no inversion; they have the word order of a declarative sentence.

Indirect general questions are introduced by the conjunctions **if** or **whether.** In indirect special questions the interrogative pronouns and adverbs turn into conjunctive pronouns and adverbs.

When orders and requests are changed into indirect speech, the Imperative Mood is replaced by the infinitive and the reporting verb **to say** is replaced by **to ask**, **to tell, to order** or their synonyms.
